# CAMPGROUND VISITOR INFORMATION

Welcome! The U.S. Army Corps of Engineers maintains and operates these campgrounds for your enjoyment. Please look over and abide by the following rules which were made for your safety and the protection of the natural resources you will enjoy. Please contact one of the Park Rangers, fee attendants or volunteers in the area should you have questions or need assistance. Helpful maps and other brochures about the park are also available from these individuals or at the Visitor Center. Also, please report any problems you encounter in the campground so that we may take appropriate action to resolve them. Our goal is to make your visit a pleasant one.

## Campsite Reservations

Sites that may be reserved are indicated on the campground map on the reverse side. To make a campsite reservation, please contact the National Recreation Reservation Service (NRRS) toll free at 877-444-6777 or on-line at [www.recreation.gov](http://www.recreation.gov). There is no reservation fee. Reservations must be made two days prior to the arrival date.

Have the following information available when making a reservation:

- The name of the park and the campground
- The campsite number or type of site desired
- Arrival and departure dates
- Golden Age/Access Passport or America the Beautiful Senior/Access card number (if you have one). This number must be provided at the time the reservation is made in order to receive the discount.
- Credit card number: Visa, Master Card, Discover, and American Express are accepted. Bank cards are also accepted.

Please note, reservations cannot be made by calling the local Lake Red Rock project office.

## Group Camping Areas

There are two group camps in the Whitebreast campground. Each group camp is rented as a single block of sites. Group Camp 1 includes sites 114-125 (\$216.00 per night) and Group Camp 2 includes sites 126-132 (\$126.00 per night). Both group camps may be reserved by calling the National Recreation Reservation Service at 877-444-6777 or on-line at [www.recreation.gov](http://www.recreation.gov).

Golden Age/Access or America the Beautiful Senior/Access cards do not apply toward the rental of group facilities.

## Wheelchair Accessible Sites

Sites #130 and #140 in Howell Station Campground and site #6 in Wallashuck Campground are available to users confined to wheelchairs for campsite reservations through the National Recreation Reservation Service (NRRS). Contact NRRS toll free at 1-800-877-444-6777 or on-line at [www.recreation.gov](http://www.recreation.gov). If not reserved, these sites are also available to users confined to wheelchairs on a first-come, first-served basis for up to 14 days. If not reserved or occupied by wheelchair users, these campsites may be rented to anyone only after all other campsites in that campground are rented. Under these circumstances, non-wheelchair users may occupy the campsite(s) until 4 p.m. on the following Monday.

# CAMPGROUND RULES

1. Camping is permitted only at designated camping sites on a first-come, first-serve basis or by reservation where specified.
2. Camping units are restricted to one wheeled unit and one tent, or two tents per site.
3. A maximum of eight persons per campsite is allowed.
4. Parking or driving motor vehicles on the grass is not allowed. Please inform your visitors of this rule. *Boat trailers may be parked on the grass due to the limited amount of space available.*
5. Motor vehicles shall be used only to enter or leave the campground, individual sites or facilities.
6. Motorized scooters are considered to be a motorized vehicle. Unlicensed motorized vehicles are not authorized on project roadways. This includes unlicensed mopeds, scooters, golf carts, etc. All ATV's, regardless of licensing, are prohibited. All drivers of authorized motor vehicles must have a valid operators license for public roadways. No motor vehicles may be operated off roadways.
7. Checkout time is at 4:00 p.m. the day the camping permit expires.
8. Quiet must be maintained between the hours of 10:00 p.m. and 6:00 a.m. Only registered campers are allowed in the campgrounds between 11:00 p.m. and 6:00 a.m. Visitors must leave the campground by 11:00 p.m.
9. Campers shall keep their sites free of trash and litter during their occupancy and shall remove all personal equipment and clean their sites upon departure.
10. Gray water must be disposed of in sewage dump stations.
11. All pets must be kept on a leash under six feet in length or otherwise physically restrained. Pet waste must be removed and disposed of properly.
12. Fires are permitted only in fire rings, fireplace grills or charcoal burners. Extinguish fires prior to departing.
13. Only dead wood on the ground can be collected for firewood. Do not destroy, deface or otherwise injure any standing timber or other vegetation.
14. The possession of loaded firearms, bows and arrows, projectile firing devices, fireworks and explosives of any kind is prohibited.
15. Overnight occupancy is not required of registered campers. This is a change in Title 36, Corps of Engineers Regulations from past years.
16. No kegs are allowed on Corps of Engineers property unless authorized by a permit.
17. The speed limit in the campground is 15 mph.
18. During the period of Memorial Day through Labor Day, no camper or camping unit is allowed to stay within one campground for more than 14 total days within any 28-day period. Prior to Memorial Day and after Labor Day, campers are not restricted by length of stay within one campground. During this early and late period, no camper or camping unit is allowed to stay on one campsite for more than 14 total days within any 28-day period.

## Campsite Registration Procedures

1. Upon entering the campground, choose an unoccupied site. Occupied sites will have a "Site Occupied" card attached to the campsite number post. Reservable sites will have an "R" on the post. Please check with the fee attendant to see if a reservation has been made before setting up on a reservable site.
2. Leave your camping equipment on the camp pad and return to the Fee Collection Booth within one hour to register and pay your fee. Your camp pad number and car license number are needed to register. If the fee booth is closed upon your arrival, come back to register within one hour after the booth reopens. Fee booths are open 9-11 a.m. and 3-10 p.m. (Fri./Sat.) and 9-11 a.m. and 3-8 p.m. (Sun.-Thurs.).
3. Campers are encouraged to pay for their entire stay when they arrive. Payment of camping fees must be kept current. Registered campers will display a current "Site Occupied" card on their site post.
4. Individuals may only rent one campsite for their personal use. Campers are not allowed to register for individuals other than themselves. The future occupant of a campsite must be the one to register for that site. The only exception to this rule are individuals reserving campsites through the National Recreation Reservation Service (NRRS).
