**B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):**

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. Summarize overall biological, chemical and physical functions being performed: The wetland above provides for nutrient and sediment reduction in the watershed. It also provides for riparian habitat and stabilization to the unnamed tributary, as it abuts the waterway. Only a portion of the USFWS mapped wetland was identified above as the wetland abuts both the unnamed tributary and Buffalo Creek.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:**

These wetlands filter waters high in nutrients from surrounding agricultural use. Nutrient rich waters, which negatively impacts water quality, is a problem not only in Iowa, but throughout the Mississippi Valley. Flow from the wetlands to the waterway and eventually the TNW happens intermittently, which provides a significant contribution of water quality improvement. These wetlands and the unnamed tributary also provide habitat for aquatic and terrestrial species and organic compounds certainly flow from the unnamed tributary to the TNW, which provides key elements for aquatic life and food chain benefits. The wetlands also provide for floodwater attenuation as small precipitation events are held in the wetlands and slowly released downstream. The tributary and the wetlands have an in-tact riparian coordior which offer a significant ecological benefit to wildlife that use headwater steams and adjacent habitats. The wetlands and the unnamed tributary do have a significant nexus to the Mississippi River.
