C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

 - Prior to the Jan 2001 Supreme Court decision in "SWANCC," the review area would have been regulated based solely on the "Migratory Bird Rule" (MBR).
- Waters do not meet the "Significant Nexus" standard, where such a finding is required for jurisdiction. Explain: **PEM #1 is a 0.93 acre palustrine emergent wetland located in a depression in the SW corner of the 10.5 acre review area. The adjacent surface drainage flows into the depression but cannot drain out. Primary vegetation species had an indicator status of FAC, and other species encountered within it's boundaries were FACW and OBL. The on-site wetland delineation was conducted during drier than normal conditions and it is common to have this seasonal wetland dominated by annual weeds with drier indicators, as was the case for this determination. Based on topographic maps from 1923-1982, there are no blue line waters near the review area. The entire area, and the land north of Monmouth, is on a large flat area with the most likely drainage pattern, based on contours, is to a tributary of the Cedar River with flow to the NW that has been tiled and converted to a grassed waterway. The closest aerial straight miles to this grassed waterway from PEM #1 is 0.60 miles. There is no connection by utility line/culvert/tile/underground hydrology, overland flow, or direct connection to a jurisdictional waters of the US.**

B. ADDITIONAL COMMENTS TO SUPPORT JD: PEM #1 is a 0.93 acre depressional, isolated, wetland, dominated by Setaria verticillata - hooked bristlegass, with an indicator status of FAC. There is no outlet or direct connection to a WUS. The nearest WUS, a grassed waterway, is 0.6 straight aerial miles away. The site has no nexus to interstate commerce, no fish or shellfish could be taken from it, no fish can be harvested or caught and sold across state lines, and no boat could be floated on it. PEM #1 is an isolated, non-jurisdictional, wetland..
