This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The review area contains one jurisdictional wetland approximately 5.5 acres in size. A NRCS Wetland Determination was used to identify these wetlands, as the project review was for a wetland enhancement project and was considered acceptable considering the nature of the proposal. The review area also contains 73.9 acres of "PC" lands. These lands are currently identified as non-jurisdictional but may contain areas that meet the definition of wetland, in accordance with the Corps of Engineers Wetland Delineation Manual (1987 Manual) and the appropriate Regional Supplement. If land use changes onsite or development plans change or are revised, an updated Approved Jurisdictional Determination would be required to adequately assess all aquatic resources. The project area also contains farm lands outside of the areas identified in the NRCS Wetland Determination. These lands were identified as upland after 2 wetland delineation points were recorded by using the Corps Delineation Manual and relevant supplements..

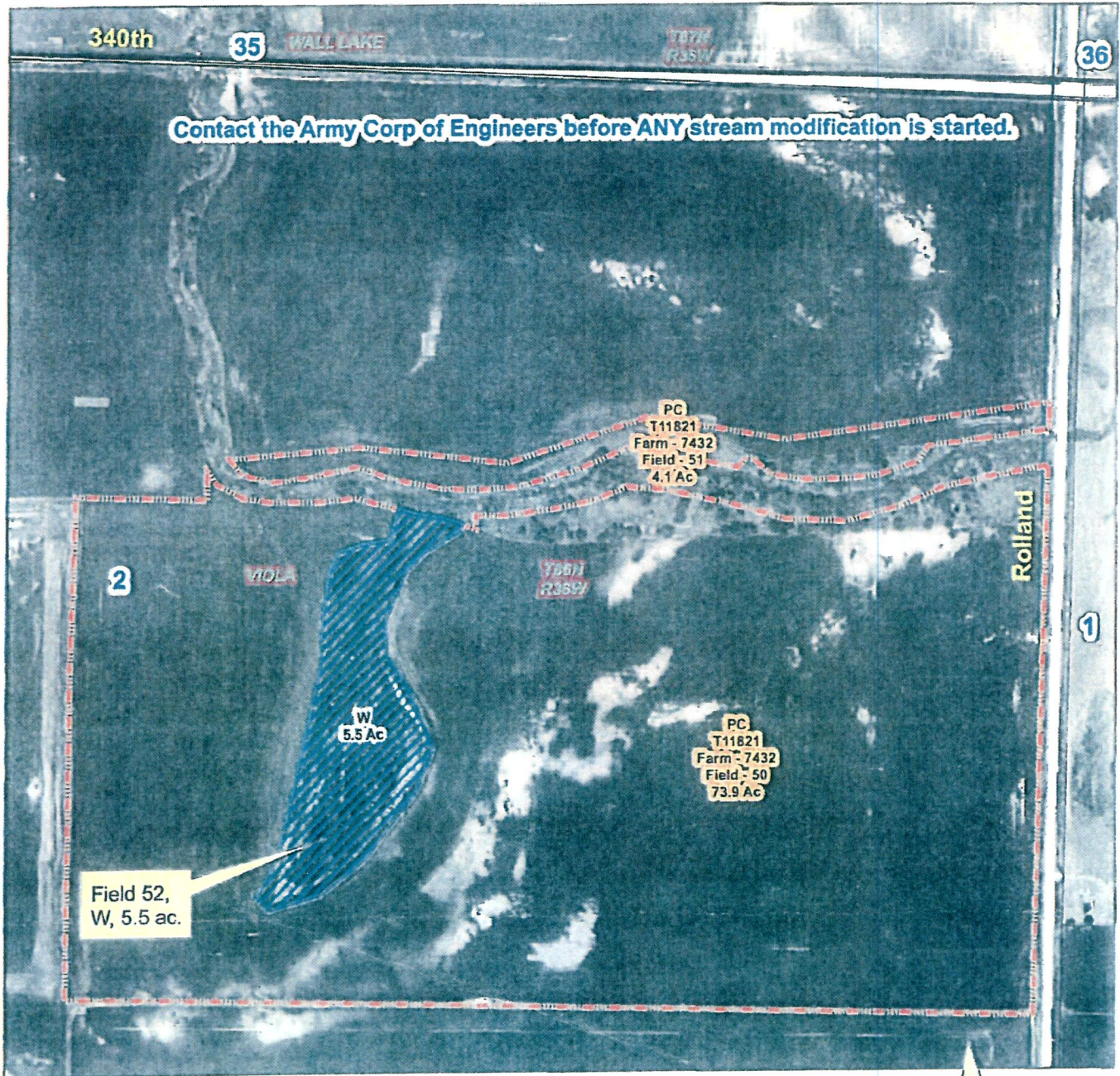
