**B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND:** Based on topographic maps sometime between 1945-1970 fill was brought into the project site and houses were constructed. The 2.4 acre project area is approximately 5’ higher than the shoreline of the Rock River. The two data points taken were each missing 1 secondary hydrology indicator. Our office visited the site on June 23, 2017, to verify no other hydrology (primary or secondary) were present. No other hydrology indicators were located in this previously disturbed site. The review area contains no aquatic resources.
