### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:**

- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to carry pollutants or flood waters to TNWs, or to reduce the amount of pollutants or flood waters reaching a TNW?

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The 51.2 acre farmed wetland is located in the western border of the Des Moines Prairie Pothole Region of the Midwest. Based on a review of available topographic maps, LiDAR, Google Maps, and Historical Imagery, the 51.2 acre farmed wetland does not have a connection to a WUS. The site has no nexus to interstate commerce, no fish or shellfish could be taken from it, no fish can be harvested or caught and sold across state lines, and no boat could be floated on it. There is no overland surface flow connection connecting the 51.2 acre farmed depressional wetland to a WUS. The Corps has determined that the 51.2 acre farmed wetland is isolated and is not jurisdictional under Section 404 of the Clean Water Act.
