**B. Typical year assessment(s):** [The Antecedent Precipitation Tool \(APT\) was used to assess conditions for two dates, 10/16/18 and 7/15/2020. Wetter than Normal conditions \(wet season\) on 10/16/20 – minor hydrology indicators shown on aerial imagery. Normal Conditions \(dry season\) were present on 7/15/2020.](#)

**C. Additional comments to support AJD:** [No defined channel with OHWM or bed and bank present. Site and aerial photographs indicate the presence of an isolated depression within the review area extending underneath the roadway bridge. The isolated wetland does not meet any of the criteria necessary to meet the definition of an \(a\)\(4\) water including a direct hydrologic surface connection with an \(a\)\(1\)-\(3\) water.](#)
