LOCATION MAP



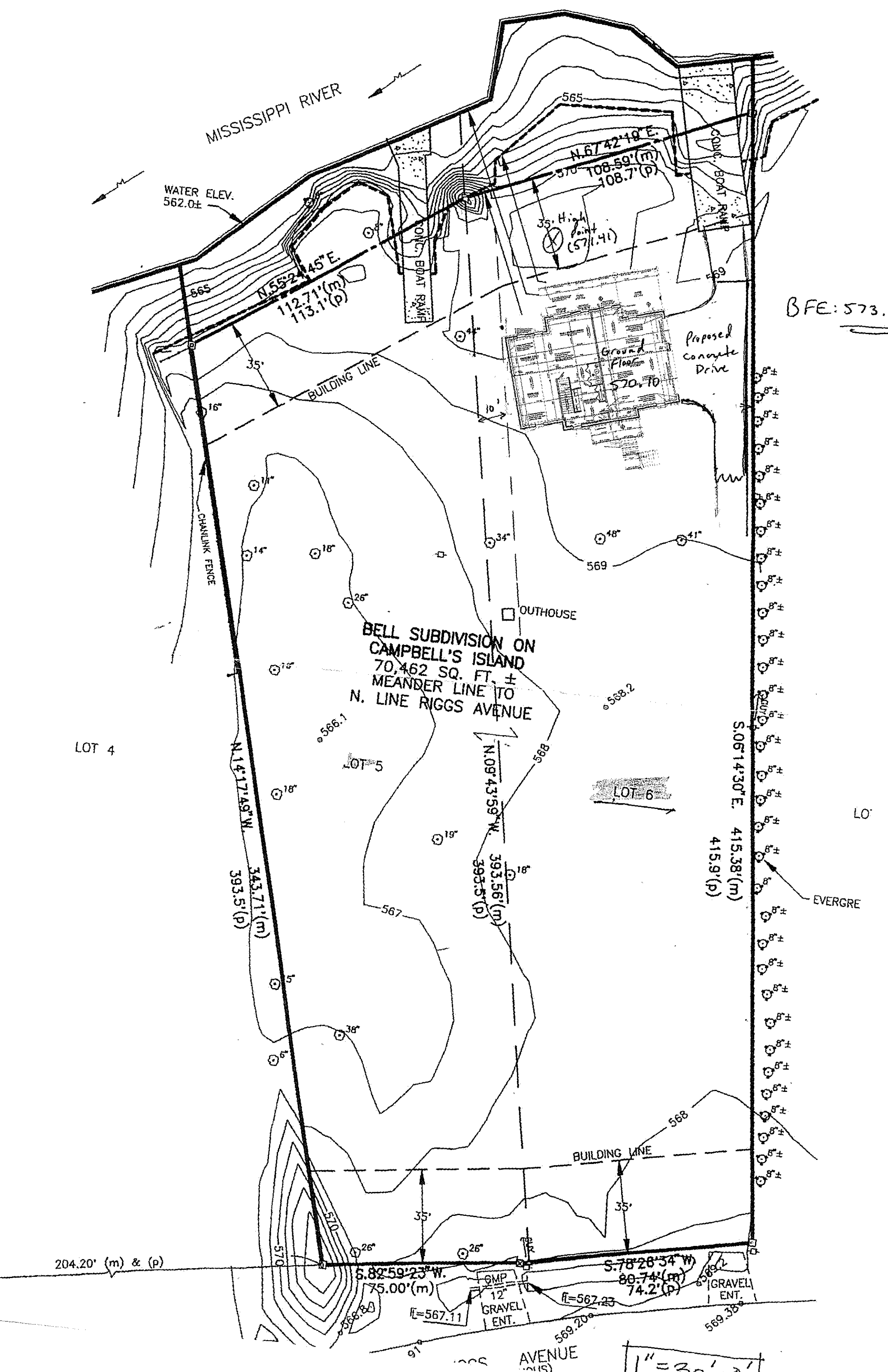
