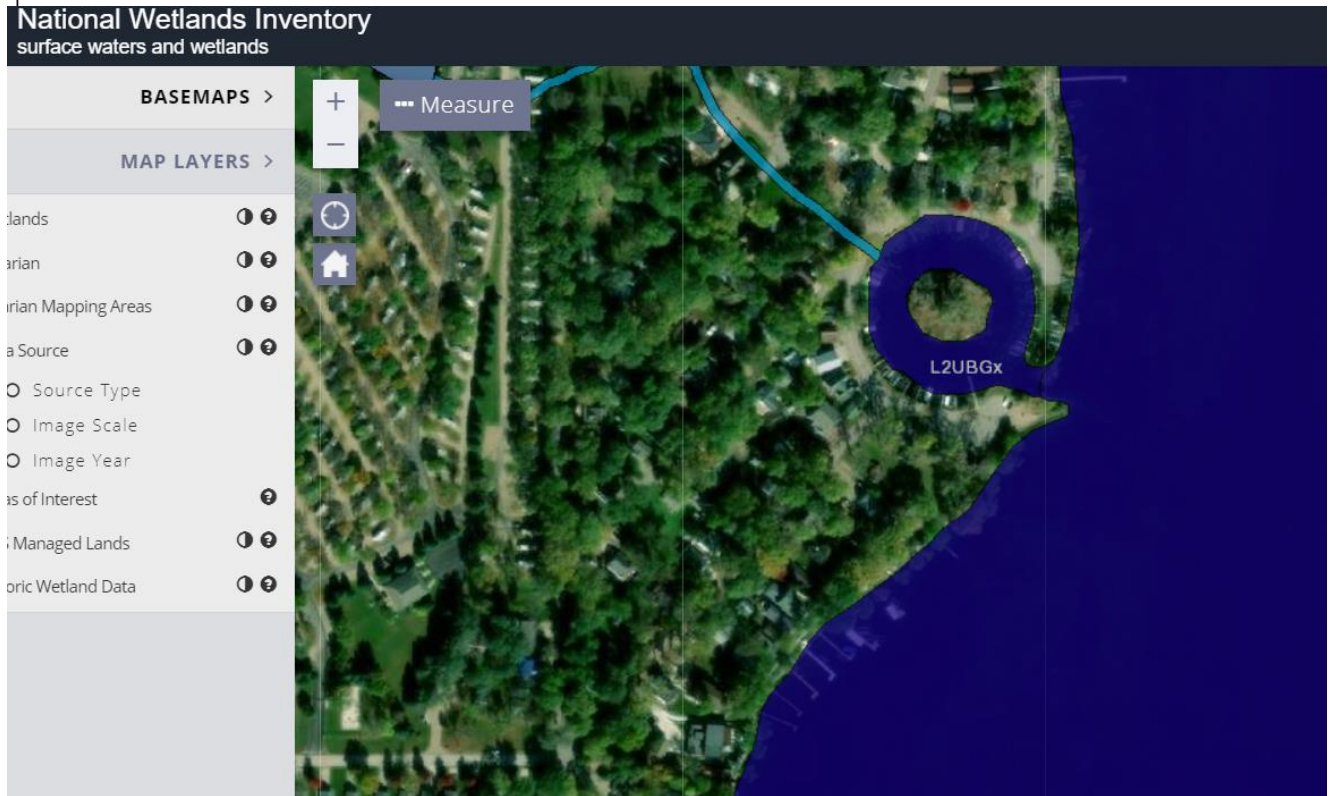

Pipeline Crossings: We would work with the utilities to determine appropriate depth but approximately 4 feet or to the natural water line whichever is first. The width would be the width of the small backhoe approximately 12-24 inches. Length will be width of the lot approximately 25 feet. The location will be rear 1/4 of the lot where it best suites due to 3 large Cottonwoods in the City owned adjacent property. No Fill, or effect to a stream or wetland. This will not effect the Triboji Lagoon.

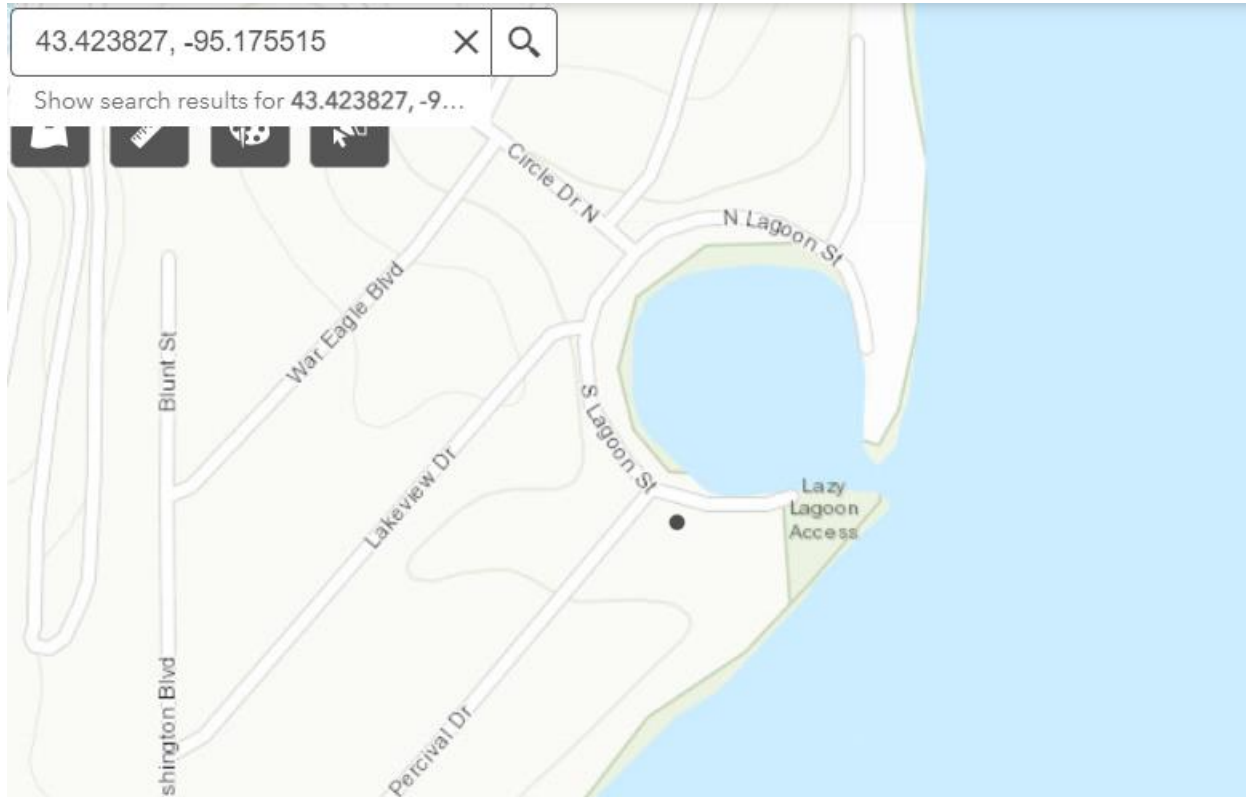
