This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). side of on-site railroad tracks, enters a culvert that runs eastward under the tracks, then enters an agricultural field where part of the stream is surficial and part of it appears to enter a subsurface drain that discharges/surfaces downstream near the confluence with Stream 2 with the surficial portion of Stream 1. From the confluence with Stream 2 to the confluence with Panther Creek (off-site), the stream appears to be "natural". Stream 2 also originates from a tile drain on the west side of on-site railroad tracks, crosses under a farm road via culvert, then crosses under the rail road and enters into a drop box that carries Stream 2 subsurface via pipe to an outlet into Stream 1 immediately before Stream 1 enters a forested area in the southeastern portion of the project site. Stream 2 is shown as a blue line stream on USGS topographic maps and an intermittent stream in NWI data; however, there was no apparent surface flow of Stream west of the mapped area. Furthermore, on the east side of Highway 4, where Stream 2 is shown, there is was no apparent water flowing into subsurface conduits, and no surficial characteristics necessary to be designated a "stream" were apparent. Based on this observation, Stream 2 appears to originate from tile drainage as shown on the attached Exhibit 6 - Wetland Delineation Map.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

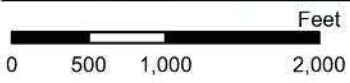
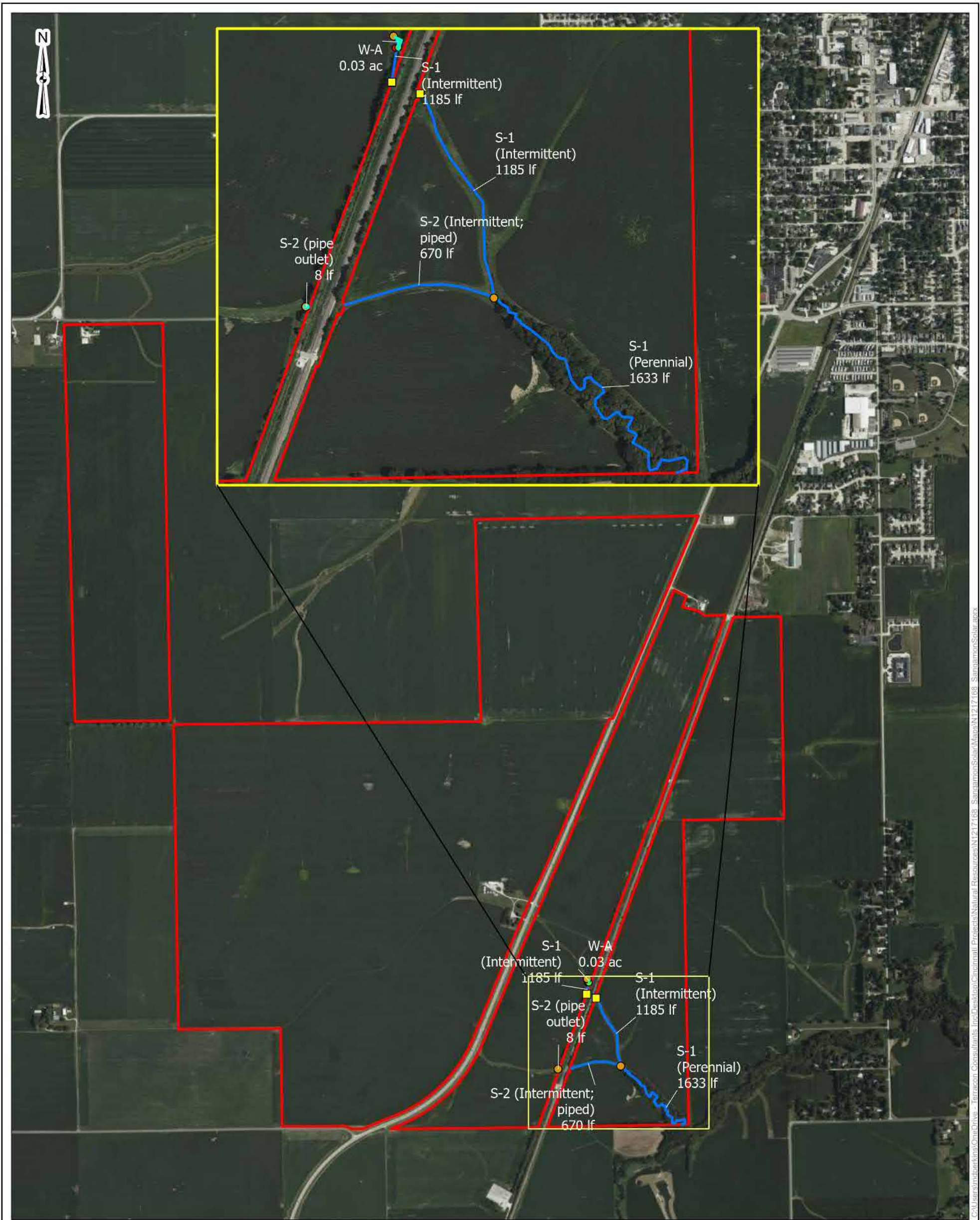
