**B. Typical year assessment(s):** The APT was run for two dates: November 14, 2014, for the previous AJD; and June 27, 2021, for this AJD. The APT showed normal conditions for the 2014 date and dry conditions during a drought for the 2021 date.

**C. Additional comments to support AJD:** The previous AJD stated that there were no waters on site. The NHD and NWI show no waters on site. There are hydric soils on site but LIDAR does not indicate the presence of a stream or wetlands.
