not appear to be an agricultural tile connection downstream. The entire area is a depressional bowl surrounded by uplands within the prairie pothole region of Iowa. The 0.46 acre farmed wetland and perennial drainage ditch do not have a downstream connection to a TNW and are therefore not jurisdictional under Section 404 of the Clean Water Act.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetland 1 is a 0.46 acre farmed wetland and WUS-1 is a 330 linear foot perennial drainage ditch excavated sometime between March 2015 and March 2016. There is an overland flow connection from Wetland 1 through the 141st Street roadside drainage ditch to WUS-1. WUS-1 connects via a culvert to the north under Iowa Street to a 26th Street roadside drainage ditch. There is a potential flowpath through a drainage pattern in the agricultural field to the NW. Based on the APT calculator the delineation was conducted under normal conditions in the wet season. There is no further potential downstream connection through a culvert, an overland flow connection, and there does not appear to be an agricultural tile connection downstream. The surrounding area, which includes the project area, is a depression bowl surrounded by uplands within the prairie pothole region of Iowa. This wetland and tributary were determined to be non-jurisdictional due to lack of direct stream connectivity or a feasible connection point that could serve as a significant nexus to a downstream regulated resource.
