B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND: The project entails an established campground renovation that doesn't appear to show any construction occurring below the OHWM of Lake Ahquabi or fill being placed in a potential wetland. The campground is largely higher elevation and lacks necessary wetland characteristics to request a delineation to investigate the potential for regulated aquatic resources.
