B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND: Project details an established fuel bulk expansion. The area of impact is entirely within the premises of the applicants property per their submitted application, aerial image, and hand drawing. The area to be filled is of high elevation and not near any potential jurisdictional aquatic resources. No wetlands are suspected to occur within the project area due to it's existing disturbance, high elevation, lack of quantifiable vegetation, and no apparent source of hydrology.
