## 31<sup>ST</sup> ANNUAL MISSISSIPPI RIVER PROJECT FORESTRY COORDINATION MEETINGS

This marks the 31st year that the Mississippi River Project has met with our managing agencies partners regarding forest management on project lands. Participants included the Fish and Wildlife Service, Illinois Department of Natural Resources, Missouri Department of Conservation, and Iowa Department of Natural Resources and all three Upper Mississippi River Corps districts at our annual Forestry Coordination Meetings in February. Approximately 85 percent of the federal lands designated to the Corps of Engineers for the 9-foot Channel Project (the system of locks and dams) are part of and managed by several national wildlife refuges and state wildlife management areas through cooperative lease agreements. The Corps works cooperatively with the agencies to manage the forested resource with wildlife habitat and forest sustainability being the primary goals. Mississippi River Project lands, in the Rock Island District, total over 54,000 acres of mainly forested shoreline and islands that stretch over 314 river miles. This constitutes a significant portion of habitat along the Mississippi flyway which is used by eagles, waterfowl, songbirds, shorebirds, and many other migratory and resident species as well as many state and federally listed species.

### THOMSON CAUSEWAY TO REMAIN CLOSED TO CAMPING UNTIL MAY 20, 2011

The U.S. Army Corps of Engineers Mississippi River Project announces: the Thomson Causeway Recreation Area will not open for camping until May 20, 2011. This is due to a delay in the construction of improvements to the sanitary facilities leaving the area without sewer or water. The area will remain open for day use activities; such as boat launching, fishing, and picnicking.

When complete, the improvements will include: partial renovation of the two existing shower facilities, construction of a new shower building, Thomson city sewer and water brought into the recreation area to serve existing facilities, and a renovated multi-lane dump station along Lewis Avenue. ## Mississippi River Visitor Center News

### VISITOR CENTER PRAIRIE AREA GETS CLEANED UP BY FIRE

You may have seen the fire and smoke coming from the Locks and Dam 15 area of Rock Island Arsenal this weekend. Rock Island Arsenal Fire Department provided a 'prairie burn' of the Mississippi River Visitor Center prairie garden areas. We have had many people calling and asking what the benefits of burning a prairie would be. The following information may answer some of your questions regarding the burn.

#### Why does the Visitor Center burn their prairie gardens?

While fire is often viewed as destructive the truth is that it is a necessary part of nature. Many habitats in Iowa & Illinois rely on fire to maintain them. Without occasional fire grasslands and wooded areas become overgrown. Many times the extra growth is non-native plants and shrubs that choke out the native vegetation. Occasional fire keeps things in check. It burns away the dead material which has accumulated from last year's growth allowing new growth to take over. Burns also kill the non-native plants which are intolerant to the fire. The deep-rooted native prairie plants are capable of withstanding the heat and are not affected.



**Does the benefit outweigh the blackness?**

The benefits of a natural fire (in our case a man made fire) far outweigh the temporary charred appearance. The black only lasts for a week or two but the benefits of the controlled burn last much longer. Among them are:

- Nutrient recycling
- Helps with seed germination by exposing soil to the sun earlier in the year.
- Controls non-native plants and invasion of woody plants
- Maintains natural habitats that some species rely on like birds and butterflies. We also have a family of rabbits that call our prairie garden home.

**How long have controlled burns been in practice?**

Fire has been used historically by Native Americans as well as early settlers. The Native Americans understood fire's importance in maintaining their hunting grounds and habitats. Early settlers used it to clear land. In the early 1900s fire suppression was adopted. This was an invitation to non-native and invasive plants to take over many prairies and forest areas. We have since learned that the 'once practiced' controlled burns are extremely beneficial to both plants and animals. So the next time you see a charred forest or prairie in the spring or fall be thankful that these natural areas are being cared for. The end result is a healthier, more natural area, even in our small prairie gardens at the Visitor Center. **HISTORIC CLOCK TOWER TOUR – APRIL 9<sup>TH</sup> & 10<sup>TH</sup>**

The U.S. Army Corps of Engineers Mississippi River Project announces that the Visitor Center at Locks and Dam #15 is offering a historical tour of the Clock Tower Building on Saturday, April 9th and Sunday April 10th from 9:00-10:30 am. It has been a community landmark since it was built in the 1860's as the very first Rock Island Arsenal building. The Clock Tower has also been the subject of interest and curiosity for many visitors and residents of the Quad Cities area. Let an U.S. Army Corps of Engineers park ranger lead you back into history. Come learn the building's secrets and find out exactly what makes that clock tick.

The program will begin at the Mississippi River Visitor's Center, located on the west end of Arsenal Island at Locks and Dam #15. This program is free of charge. Advance registration is required.

For security reasons all persons over age 16 must carry a photo ID to enter the island. Vehicles are subject to search and participants should allow 15 minutes extra to ensure proper arrival time for the program.

**BOATING SAFETY CLASSES OFFERED**

The U.S. Army Corps of Engineers Mississippi River Project announces they will be offering five different opportunities to attend a **free** boating safety education class. The classes will be held on the following dates: April 2<sup>nd</sup>, April 16<sup>th</sup>, April 30<sup>th</sup>, and May 14<sup>th</sup>, 2011. Each class will run from 8:00 a.m. - 4:30 p.m. and only one class is required to complete your certification. This class is recommended for people who are new to boating on the Mississippi, families that enjoy weekend boating adventures, or seasoned boaters who would just like to brush up on their safe boating knowledge. Anyone over the age of 12 can be certified. This is a classroom based safety course and will not include an on-the-water experience. Upon successful completion of the class and exam, participants will be issued an Illinois DNR Boat Safety certification which is honored in both Iowa and Illinois. These classes will be held at the Mississippi River Project Office at Locks and Dam 14 in Pleasant Valley, Iowa.

## Quincy Ranger Station News

### FREE BOAT CLASSES OFFERED

The Quincy rangers will be offering boating safety classes for the spring and summer seasons. If you are interested in operating a boat in Illinois and are between the ages of 13-18, boating education is required. However, boating education is valuable knowledge to be had by all boat operators and passengers, especially on dynamic bodies of water, such as the Mississippi River. All classes will be held at the Quincy Boat Club in Quincy, IL and is an 8 hour class with course subjects including: Basic Boating Safety; Equipment requirements; motorboat registration and titling; Illinois boat laws (Missouri & Iowa laws can be applicable and discussed due to geographical location); Navigation; Personal watercraft; and Emergency Measures.
