### **River Returning to "Normal" for End of Summer**

#### CORPS RANGERS SCHEDULED TO ASSIST WITH WATER SAFETY EFFORTS DURING FLOATZILLA PADDLING EVENT



Each summer thousands of paddlers flock to the Mississippi River to participate in a large event known as FLOATZILLA. This event gives people of all skill levels a chance to get out and experience the mighty Mississippi from a different angle. This year there will be two launch sites located up stream of Locks and Dam 15 where paddlers will enter the river and get the opportunity to lock through. The ranger staff with the Mississippi River Project will be helping approximately 500 paddlers to safely pass through the locks and be on their way down stream to Sunset Park in Rock Island, IL. The goal is to have all participants meet at the park by 2:00 PM for an attempt at a Guinness world record for the largest flotilla of canoes and kayaks. Paddling on the Mississippi River can be a fun and exciting experience however many hidden dangers lurk beneath the surface of the water. The rangers who will be assisting the participants in this year's event will focus on safety by reminding everyone about wearing life jackets and the importance of staying away from the hazards in the river like dams, lateral walls. and fallen trees. #### FOREST RESTORATION ALONG THE MISSISSIPPI RIVER

Forest restoration projects within the Bottomland Floodplain Forest of the Mississippi River have their challenges. One would think the easiest way to have an immediate impact on the present forested conditions would be to plant a tree and walk away. Unfortunately, the plant and walk away method doesn't work very often given the unforeseen variables the Mississippi River system offers for bottomland hardwood forest management. Hard-mast trees are nut producing (oak, hickory, pecan) trees which are less tolerant to flooding than soft-mast light seeded (maple, cottonwood, ash, elm) trees. Elevation within the floodplain forest is taken into consideration to determine what species of trees have a higher probability of survival given current elevations. Twelve inches of increased elevation also increases site suitability to allow for

a more diverse mix of tree species to be planted since there is less frequency of flooding. Incorporating a diverse mix of tree species into a planting allows for added insurance if an individual tree species becomes susceptible to insects, disease, herbivory, invasive species, flooding, etc... Flooding can cause mortality to planted trees through a variety of factors to include depth, duration, and frequency of occurrence. The longer trees are exposed to flooded conditions, the higher probability of stress, injury or death is to occur. Sediment deposition can also be observed following flood events which increase terrestrial



elevations but sediment also settles out in overwintering fish habitats leaving them unsuitable over time. Long Island is one of those areas, open to the general public, where cooperative forest restoration is occurring even though the island continues to see its share of adverse conditions.

Long Island is a 6,300 acre area that is cooperatively managed with USFWS Great River National Wildlife Refuge as part of Long Island Division located in Adams County, Illinois, in pool 21 on the Mississippi River. Long Island is comprised of several islands of which the complex is rich with backwater sloughs, forested wetland, swamp privet/buttonbush shrub scrub, and other wetland areas. Corps and FWS personnel have worked diligently to reforest open canopy areas and previous agriculture leased areas with a diverse mix of hard and soft-mast tree species. Once a tree planting has commenced, follow-up site maintenance is required to ensure trees have an opportunity to reach maturity where they are able to provide multiple benefits for different wildlife community types. Tree planting maintenance generally requires herbaceous vegetative control after establishment for several years. Controlling invasive non-native species and aggressive native herbaceous species is necessary since several of these plants demonstrate the ability to out-compete desirable tree species for sunlight, space, and nutrient uptake. Competition from soft-mast light seeded tree species. Once tree plantings become established



over the course of 10 years or so, a crop-tree release may be performed to reduce competition, promote vertical height growth, and increase canopy development over time. A crop-tree is defined as a desirable tree selected to benefit from efforts of removing adjacent woody competition through cutting and/or girdling. Girdling of trees provides multiple benefits to wildlife and avian communities since live trees become standing dead trees or snags. Cavities become easier to construct for certain species of birds for nesting and brood rearing purposes. As standing trees start to decay, bark begins to exfoliate, leaving tight crevices between bark and main stem of the tree. Crevices allow for ideal habitat for species like endangered Indiana bat (Myotis sodalis) to rest and roost in.

#### MAIN SIDE OF PLEASANT CREEK RECREATION AREA REOPENS

The Pleasant Creek Recreation Area is rustic and relaxing with a front row seat of the main channel of the Mississippi River. The main land camping area and boat ramp have been closed for much of the summer due to high water but have now reopened for public use. The island side of the recreation area remains closed and is still in need of clean-up efforts. Pleasant Creek Recreation Area is located 3 miles south of Bellevue, Iowa, along Highway 52 and has a number of first-come, first-serve campsites, drinking water, and vault toilets. There is no electrical service or flush toilets making this a perfect spot for primitive campers. The area also has a sewer dump station and concrete boat ramp with direct access to the main channel. Recline in your lounge chair and watch the river traffic navigate up and down the river below Lock & Dam 12.

#### **THOMSON CAUSEWAY FUN FACT**

The "Sandburr", also referred to as "Bur Rageweed", is considered a weed in most parts of the US, but not here. In 1975, the Village of Thomson, Illinois voted to recognize the sandburr, Ambrosia 'Franseria' acanthicarpa, as the official

plant and emblem of the town. Thomson considers the sandburr a rare and exotic plant, and can be found in the area because of the unique sand prairies.

According to the National Park Service, the genus name, "Ambrosia", originates from Greek mythology which was the food of the gods and refers to the sweet smelling odor of this plant. The previous genus "Franseria", which was given to various shrubs in out West, honors Antonio Franseri, an 18th-century Spanish botanist. The species name, "acanthicarpa", means "with thorny fruits like those of Acanthus", hence the common name Sandburr.

#### FREE WEEKDAY TOURS OF LOCKS AND DAM 15

The U.S. Army Corps of Engineers Mississippi River Project announces they will be offering to the public free weekday tours of Locks and Dam 15. These special tours will be conducted on Mondays and Friday mornings from 11:00-12:00 (weather permitting). These tours will run through August 23rd.

Participants must wear shoes with enclosed toes and backs, tennis shoes are preferred. Purses, bags, cameras and pictures are not allowed on the tour but they are allowed in the Visitor

Center. Walking is required. Pre-registration is also recommended as the group size is limited and tours sometimes fill fast.

If you do not have time to attend tours then just stop by for a visit. The Mississippi River Visitor Center gives you a great view of the locking process at Locks and Dam # 15. There is a picnicking area, restroom facilities, observation deck and an indoor theater. The center is located on the west end of Arsenal Island in Rock Island, Illinois and is open 9:00am till 5:00pm daily.

The facility is only accessible via the Rock Island or Moline entrances. All persons over the age of 16 must carry a photo ID in order to enter the island. All vehicles are subject to random search and participants should allow 15 minutes extra to ensure proper arrival time. Pedestrians and bicyclists with helmets have access to the Mississippi River Visitor Center through the Rock Island gate only. Appropriate ID is required.

#### LOCK AND DAM #16 TOURS

The U.S. Army Corps of Engineers Mississippi River Project invites the public to enjoy a tour of Lock and Dam #16. Every Sunday from May 26, 2013 through September 1, 2013 at 2:00 PM, weather permitting, tours of Locks and Dam #16 will be conducted for the public. A special Labor Day weekend tour will be held on Saturday, August 31, 2013 at 2:00 PM. Lock and Dam #16 is located off 102nd Ave West on the Illinois side of the Mississippi River about one mile upstream from the bridge in Muscatine, IA. Participants will be presented with a history of the Upper Mississippi River system, how the river system operates and the process it takes to move a barge through a lock. The tour is capped off with a walk on the lock structure. Walking is a part of the tour, so participants must wear shoes with enclosed toes and an enclosed back (tennis shoes are best).
