Gearing Up for a Safe Summer

Each summer you will find our US Army Corps of Engineers park rangers from the Mississippi River Project working on both land and water to keep our recreational users safe. Although safety in our parks is very important, safety on the water is a high priority. You may sometimes see our rangers working on the river on water safety patrol where they enforce federal regulations to keep boaters safe. Other times you may find rangers at the boat ramps offering courtesy inspections of vessels to assist people with knowing what is needed before they get out onto the water. Throughout the Project our rangers also take time to help educate people of all ages by offering boating safety classes and hosting eco-meets for local school groups. In this month's newsletter you will learn about the many ways the Mississippi River Project is working to keep you safe.

BOATING SAFETY CLASSES GET BOATERS READY FOR THE SUMMER

Each spring the park rangers with the Mississippi River Project offer boating safety education classes for boaters of all ages and experience levels. These classes are taught in cooperation with the IL Department of Natural Resources and provide a great deal of information for new boaters as well as seasoned veterans that have been boating for years. Some of the topics covered during the class include basic terminology used when boating, required equipment needed on a boat, and safe operation on the water. These eight hour classes allow participants to ask questions of the rangers as well as conservation officers about how to stay safe on the river. They also cover information on using a navigation chart and how to take a private vessel through the lock.





So far this year the Project has completed 5 boating safety courses with a total of 92 participants. All 92 participants passed the class and received certification.

If you missed one of our first 5 classes and are interested in taking a class yet this year there will be two more chances to attend in the Quincy, IL area. The law requires that if you choose to operate a boat in Illinois between the ages of 12-18 that a boating safety certification is required. The dates the classes will be offered are June 11th and July 9th from 8:00 AM till 5:00 PM each day. Certification can be completed by attending either of the two classes.

SPRING ECO-MEETS GET STUDENTS INVOLVED

Each spring our Dubuque and Thomson ranger offices coordinate friendly competitions among their local area schools. These day-long events, known as Eco-meets, are a great way for teachers to give students a chance to interact with a number of agencies on a variety of topics from forestry to water safety. Each school forms a small team of students which attend the event. While at the Eco-meet, students take part in workshops where volunteers from agencies like, the lowa DNR, US Fish and Wildlife Service, and the US Army Corps of Engineers, present the students with information on a specific topic. Once the team of students has completed a workshop they are then tested on the knowledge they have gained. At the end of the day, the team who has scored highest in all the tested areas is



BICYCLE TOUR OF HISTORIC ARSENAL ISLAND

NATURE WALK SERIES-TREES

TOURS OF LOCKS AND DAM # 15 TO BEGIN FOR SEASON

The U.S. Army Corps of Engineers Mississippi River Project announces they will be offering free tours of Locks and Dam 15 starting this Memorial Day weekend and running each weekend through Labor Day.

Corps of Engineers Park Rangers will offer free lock and dam tours each Saturday and Sunday at 11:00am and 2:00pm (weather permitting). Participants must wear shoes with enclosed toes and backs, tennis shoes are preferred. Cameras and pictures are not allowed on the tour but they are allowed in the Visitor Center. Walking is required. Pre-registration is also required and the group size is limited.



If you do not have time to attend tours then just stop by for a visit. The Corps of Engineers Visitor Center gives you a great view of the locking through process at Locks and Dam # 15. There is picnicking and restroom facilities, as well as items unique to the river for sale. The center is located on the west end of Arsenal Island in Rock Island, Illinois and is open 9:00 AM till 5:00 PM daily.

The facility is accessible via the Davenport or Moline entrances. All persons over the age of 16 must carry a photo ID in order to enter the island. All vehicles are subject to random search and participants should allow 15 minutes extra to ensure proper arrival time. TOURS OF LOCK AND DAM #16 TO BEGIN FOR SEASON

The U.S. Army Corps of Engineers Mississippi River Project invites the public to enjoy a tour of Lock and Dam 16. Every Sunday from May 29, 2011 through September 4, 2011 at 2:00 PM, weather permitting, tours of Locks and Dam 16 will be conducted for the public. Lock and Dam 16 is located off 102nd Ave West on the Illinois side of the Mississippi River about one mile upstream from the Muscatine Bridge. Participants will be presented with a history of the Upper Mississippi River system, how the river system operates and the process it takes to move a barge through a lock. The tour is capped off with a walk on the lock and dam structure. Walking is a part of the tour so participants must wear shoes with enclosed toes and an enclosed back (tennis shoes are best). Advance reservations are required as group size is limited. Please allow approximately one hour to complete the tour. Quincy Ranger Station News

The boating season is just about here and much focus has been geared toward boating safety. The Quincy Rangers partnered with the US Coast Guard Auxiliary and conducted courtesy vessel safety inspections (VSI) that were free to the public. These beneficial inspections of vessels are used to inform the owners of what they legally need to have onboard, as well as provide safety information that will be useful on the river. The Rangers were able to access their parks toward the end of May after high water had made it impossible. Much work was done to get the parks and boat ramps cleaned up and ready for the holiday weekend. Unfortunately, yet not surprisingly, the Upper Mississippi River was once again inundated with what seemed to be a monsoon and all cleanup efforts were washed away as several parks went underwater again just days before Memorial Day weekend.
