CAMPGROUND VISITOR INFORMATION

Welcome! The U.S. Army Corps of Engineers maintains and operates these campgrounds for your enjoyment. Please look over and abide by the following rules which were made for your safety and the protection of the natural resources you will enjoy. Please contact one of the Park Rangers, fee attendants or volunteers in the area should you have questions or need assistance. Helpful maps and other brochures about the park are also available from these individuals or at the Visitor Center. Also, please report any problems you encounter in the campground so that we may take appropriate action to resolve them. Our goal is to make your visit a pleasant one.

Campsite Reservations

Sites available for reservation are indicated on the campground map. To make a reservation, contact Recreation.gov toll free at 877-444-6777 or on-line at www.recreation.gov. Reservations must be made a minimum of two days prior to the arrival date.

Reservations are required for all campsites in Ivans Campground and can be made at any time prior to occupying a site.

Have the following information available when making a reservation:

- The name of the park and the campground
- The campsite number or type of site desired
- Arrival and departure dates
- Golden Age/Access Passport or America the Beautiful Senior/Access card number (if you have one). This number must be provided at the time the reservation is made in order to receive the discount.
- Credit card number: Visa, Master Card, Discover, American Express, JCP and Union Pay are accepted.

Please note, reservations cannot be made by calling the local Lake Red Rock project office.

Group Camping Areas

There are two group camps in the Whitebreast campground. Each group camp is rented as a single block of sites. Group Camp 1 includes sites 114-125 (\$240.00 per night) and Group Camp 2 includes sites 126-132 (\$140.00 per night). Both group camps may be reserved by calling Recreation.gov at 877-444-6777 or on-line at www.recreation.gov. Reservations must be made a minimum of two days prior to the arrival date.

Golden Age/Access or America the Beautiful Senior/Access cards do not apply toward the rental of group facilities.



Wheelchair Accessible Sites

Sites #130 and #140 in Howell Station Campground and site #6 in Wallashuck Campground are available to users with disabilities. The sites may be reserved by calling Recreation.gov toll free at 1-877-444-6777 or on-line at www.recreation.gov. If not reserved, these sites are available to users with disabilities on a first-come, first-served basis for up to 14 days. If not reserved or occupied by users with disabilities, these campsites may be rented to anyone only after all other campsites in that campground are rented. Under these circumstances, users may occupy the campsites until 3 p.m. on the following Monday.



CAMPGROUND RULES

1. Camping is permitted only at designated camping sites on a first-come, first-serve basis or by reservation where specified.
2. Camping units are restricted to one wheeled unit and two tents, or three tents per site.
3. A maximum of eight persons per campsite is allowed.
4. Parking or driving motor vehicles on the grass is not allowed. Please inform your visitors of this rule. *Boat trailers may be parked on the grass.*
5. Motor vehicles shall be used only to enter or leave the campground, individual sites or facilities.
6. Unlicensed motorized vehicles are not authorized on project roadways. This includes unlicensed mopeds, scooters, golf carts, etc. All ATV's, regardless of licensing, are prohibited. All drivers of authorized motor vehicles must have a valid operators license for public roadways. No motor vehicles may be operated off roadways.
7. Checkout time is at 3:00 p.m. Please return your site occupied card to the fee booth when departing.
8. Quiet must be maintained between the hours of 10:00 p.m. and 6:00 a.m. Only registered campers are allowed in the campgrounds between 11:00 p.m. and 6:00 a.m. Visitors must leave the campground by 11:00 p.m.
9. Campsites must be kept free of litter at all times. Remove all personal equipment and properly dispose of trash upon departure.
10. Gray water must be disposed of in sewage dump stations.
11. All pets must be kept on a leash under six feet in length or otherwise physically restrained. Pet waste must be removed and disposed of properly.
12. Fires are permitted only in fire rings, fireplace grills or charcoal burners. Extinguish fires prior to departing.
13. Only dead wood on the ground can be collected for firewood. Do not destroy, deface or otherwise injure any standing timber or other vegetation.
14. The possession of loaded firearms, bows and arrows, projectile firing devices, fireworks and explosives of any kind is prohibited.
15. Overnight occupancy is not required of registered campers.
16. Kegs are allowed on Corps of Engineers property by permit only.
17. The speed limit in the campground is 15 mph.
18. No camper or camping unit is allowed to stay within one campground for more than 14 total days within any 30-day period.

Campsite Registration Procedures

Campers with Reservations:

1. Check-in time is at 4:00 p.m. Please check in at the fee booth upon entering the campground. If the booth is closed at the time of arrival, set up your campsite and return to the booth to check in during regular hours of operation.
2. A site occupied card will be issued at check-in. Attach the card to the site number post on your campsite.

Campers without Reservations:

1. Campsites are available for "walk-in" camping when not reserved. This does not apply for Ivan's Campground, as all sites must be reserved.
2. Place your camping equipment on an unoccupied site. Occupied sites are identified by a card attached to the campsite number post or the presence of camping equipment on the site. Check with the campground attendant to verify the site is available prior to setting up equipment.
3. Register at the fee booth. Your campsite number is needed to register. If the fee booth is closed, return to register during regular hours of operation.
4. A site occupied card will be issued when you register for the site. Attach the card to the site number post on your campsite. Please return the card to the fee booth upon departure.
5. Campers are encouraged to pay for their entire stay when they register. Payment of camping fees must be kept current.
