Explain: **The 0.336 acre emergent wetland identified on the attached maps is considered isolated. The depressional wetland area is man made and collects overland flow from the surrounding commercial development. An onsite visit was conducted and graded, upland slopes surround the wetland in all directions with a road grade on the east side of the wetland. Aerial photography, LiDAR, topographic maps and onsite photos do not show a connection to any other water. LiDAR appears to show a small slope to the South of the review area. Onsite Photo 2 shows (facing south on**

the south end of the wetland), shows there is a graded slope into the wetland area that prevents water from surface flowing to the south. One culvert (approximately 16") was observed upslope of the wetland boundary and appeared to lead under the road to the east of the wetland. No outlet of the culvert was observed on the east side of the road, and is likely part of the stormwater system. It did not appear that active flow from the wetland to the culvert occurred. The wetland does not support a link to interstate or foreign commerce.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
