The ponded area and directly abutting wetland 1 are isolated waters of the US..**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Based on topographical maps the ponded area was constructed in an upland, for a livestock ponded area, sometime between 1940-1950. Based on aerial photography, the directly abutting 2.17 acre forested (wetland 1) developed by 1951. Based on topographic maps any water leaving the ponded area/wetland 1 would most likely flow SE to Ida Creek following an abandoned railroad track route, potentially flowing through a drainage ditches or tile, for a distance of 1.51 miles. Another possible route for water to flow would be to the SW directly into the Vermillion River, potentially through tiles, for a distance of 0.56 miles. The elevation profiles for both of these potential routes for water flow have several higher elevations between the project area and a jurisdictional WUS. Water does not flow uphill, and the elevation profiles are supportive that there is no connection to a jurisdictional WUS. The ponded area and the directly abutting wetland 1 do not have a surface hydrologic connection to any nearby jurisdictional water resource. The ponded area and directly abutting wetland 1 are isolated waters of the US. These sites have no nexus to interstate commerce. The ponded area and Wetland 1 is an isolated wetland.
