Explain: **The review area contains 1.08 acres of open water pond and 1.41 acres of forested, scrub shrub and emergent wetland. The wetlands and ponds are located within depressional land features that have no surface, or shallow subsurface, connection to any other Water of the United States. The wetlands/ponds receive water from overland flow with some possible groundwater additions and have no outlet. A review of aerial photography indicates the wetlands and ponds formed within features that were excavated, in uplands, sometime in the 1970's or 1980's. Aerial photos**

prior to the excavation do not show any water features or wetlands in the review area. Soil maps and topographic maps were also reviewed and did not indicate any connections to any waters of the united states. Lidar images do not show any features that would transport water away from the site. Lidar images do show the constructed nature of the pond and wetland areas, as berms can be seen surrounding the wetlands and ponds. Special consideration was given to the potential of drainage from roadside ditches, though no connections were found. The wetlands and ponds do not support a link to interstate or foreign commerce..

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
