Explain: **Five isolated wetlands (totalling 4.94 acres) were identified within the project site. Wetlands 1, 2, 3, 4, and 7 are farmed wetlands which are isolated, depressional wetlands situated above the 500-year floodplain. There is no discreet or confined surface or subsurface connection to a tributary stream that eventually flows into a navigable water of the United States. The five wetlands lack an interstate commerce nexus.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

Pecumsaugan Creek, its tributaries, and adjacent wetlands serve to filter pollutants (sediment, chemicals, and other pollutants) from stormwater runoff from the adjacent agricultural land, roadways, and commercial development areas. Reductions of chemical, mineral, and organic pollutants have the potential to improve the habitat of aquatic and terrestrial plant and animal life living in the watershed. Finally, the Black Ball Mine Nature Preserve which serves as critical habitat for the hibernating federally endangered Indiana bat (*Myotis sodalis*) is located 7 miles downstream along Pecumsaugan Creek. Water exiting the two wetlands has the potential to directly or indirectly affect the listed species.

These farmed wetlands are situated in actively row-cropped farm land which is situated above the 500-year floodplain of any waterbody. There is no discreet or confined surface or shallow subsurface connection to a tributary stream that eventually flows into navigable waters of the United States. Therefore, the wetlands are not hydrologically connected to a water of the United States. The waters are not used by interstate or foreign travelers for recreation, or other purposes, or foreign commerce. The waters cannot be used for industrial purposes by industries in interstate commerce. The waters are not accessible for recreational boating. Fish or shellfish have not and cannot be taken from these waters and sold in interstate or foreign commerce. These isolated waters lack an interstate commerce nexus. Prior to the Jan 2001 Supreme Court decision in "SWANCC", the 4.94 acres of aquatic habitat would have been regulated based solely on the "Migratory Bird Rule"** .
