Explain: **There are two features within the project area that are not WOUS. The first feature is a 0.25 acre recreational/landscape pond that was excavated in uplands. This feature is not a natural pond and was created in dry land sometime between 1990 and 2002. Aerial photo interpretation indicates this feature was created in dry land. Small areas of wetland vegetated areas have developed on the edge of the pond, but still would not be considered jurisdictional as the pond was constructed in dry land and for recreational/landscape purposes. The second feature is**

**a 0.85 acre water treatment/storage facility. The landowner provided documentation that the feature was constructed for water treatment/storage purposes. Corps regulations state that these types of features are not WOUS (33 CFR 328.3).**

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
