other jurisdictional waterbodies. No discrete drainageways leading from the site to Waubonsie Creek are identified on the USGS topo map or in the county soil survey. The two onsite stormwater basins (one wet-bottom and one dry-bottom) are closed cells which receive stormwater runoff from the surrounding commercial developments. The majority of the wetland is located in FEMA Zone X above the 100-year floodplain of Waubonsie Creek, and local observations indicate the site has not been inundated since the Flood of 1996 .

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The water cannot be used for industrial purposes by industries in interstate commerce. The water is not accessible for recreational boating. Fish or shellfish have not and cannot be taken from this water and sold in interstate or foreign commerce. This isolated water lacks an interstate commerce nexus. Prior to the Jan 2001 Supreme Court decision in "SWANCC", the 1.9 acres of aquatic habitat would have been regulated based solely on the "Migratory Bird Rule".**
