The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. Summarize overall biological, chemical and physical functions being performed: The wetlands provide some storm water detention, sediment detainment, and pollution control. Small invertebrates would be expected to prosper in such a wetland however none were specifically observed in the delineation report. Sediment detainment is certainly occurring, due to the proximity of the wetlands to the streams providing an active riparian buffer. The functions/benefits in regards to pollution are the filtration of local herbicides and pesticides that are generally spread onto the neighboring agricultural fields, as well as the removal of any pollutants that might be attached to the silt particles prior to their entering a direct connection to the downstream TNW.

#### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- Does the tributary, in combination with its adjacent wetlands (if any), have other relationships to the physical, chemical, or biological integrity of the TNW?

- 1. Significant nexus findings for non-RPW that has no adjacent wetlands and flows directly or indirectly into TNWs. Explain findings of presence or absence of significant nexus below, based on the tributary itself, then go to Section III.D:

  - a. Snyder and Associates has identified three intermittent tributaries (Streams 1, 2 & 3) that travel from the outlet of the neighboring ag fields grassed waterway tiles into an unnamed tributary to Muchakinock Creek after it leaves the project area. The tributaries (Streams 1, 2 & 3) total 4,164 linear feet and exhibit an OHWM with a natural line impressed on the bank, presence of litter and debris, lack of vegetation, sediment sorting and scour (per description in delineation and characteristics observed in photographs). The streams exhibits a shallow <1 foot deep channel with varying widths and steep, sometimes very tall (3-35'), banks. Once the streams connect on the South East portion of the property the new stream leaves the property and it directly connects with several man-made ponds that outlet into an unnamed tributary to Muchakinock Creek, which eventually becomes Muchakinock Creek. This terminates into the Des Moines River, a TNW. The wetlands identified as Wetland 1, 2, 3, 4, 5, 6 and 7 in the wetland delineation report provided by Snyder total 4.33 acres in area, the intermittent stream located within the project area totals 4,164 linear feet and there are 0.9 acres of open water perennial pond found onsite.
  - b. The relevant reach for this wetland complex extends from the upper reaches of the intermittent streams on-site and their adjacent wetlands until they combine and eventually flow into the non-navigable, permanent ponds on the stream identified as an Unnamed Tributary to Muchakinock Creek. These eventually empty into Muchakinock Creek, which and eventually the Des Moines River. We have determined that the point where the perennial ponds directly downstream connect with the unnamed tributary to Muchakinock Creek, defines the extent of our review area due to the guidance on page 40 of the USACE Jurisdictional Determination Form Instructional Guidebook as well as the figure shown on page 41 with very similar conditions. In researching historical aerial photography the Corps has found that the unnamed tributary to Muchakinock Creek has had a direct connection to Muchakinock Creek for at least 50+ years on aerial photography even throughout the years where the areas were mined and it is identified on the USGS topographic maps with a 3 dot blue line identifying it as an intermittent waterway.
  - c. We have determined that the evaluated wetlands 1, 2, 3, 4, 5, 6 and 7 as identified by Snyder and Associates (and any other wetlands similarly situated in the watershed) possess limited flood storage capacity due to a relatively small drainage area (approximately 4.33 acres cumulatively, ~150 acres drainage area). However, they do have a significant nexus due to the large amounts of agricultural and historical mining activity in the watershed of Muchakinock Creek which has increased the frequency of flooding in the area due to a lack of riparian corridors in the watershed.
  - d. The physical hydrological connection between the wetlands and the downstream TNW is discrete as they directly abut the streams identified in the delineation and overland flow provides a direct hydrologic connection to the downstream TNW. We (Corps) have calculated that the drainage area for the wetlands is about 150 acres using the USGS topographic map and the reported conditions in the delineation by Snyder and Associates identify that the streams were observed exhibiting a moderate and intermittent flow in connection with the unnamed tributary to Muchakinock Creek. The overland hydrologic connection between the waterway and eventually the blue dot RPW identified as an unnamed tributary to Muchakinock Creek is discrete as the streams onsite eventually become this unnamed tributary as more drainage enters the stream. The wetlands are connected to the intermittent streams through overland flow and would exhibit a direct connection during all precipitation events due to their proximity to the on-site intermittent streams.
  - e. Contaminants (silt, nitrogen, phosphorus) entering the evaluated streams and wetlands due to the agricultural activities, historic remnants from mining on-site and from overland flow in the drainage area that are filtered out by the wetlands prior to reaching the Des Moines River which is a TNW. A general function of any such wetland is the filtration of contaminants which are present due to the neighboring activities. It can be reasonably assumed that the contaminants attached to the sediment particles released by plowing and other soil moving activities are being filtered as well. Other materials that are being filtered out by these wetlands are the oils and heavy metals associated with the heavy agricultural and mining machinery. These wetlands provide a significant benefit to the filtration of nitrogen that is applied on any farming properties on the upstream drainage area as fertilizer. This wetland complex provides a much needed filter to prevent contaminants and sediments from entering the watershed. The tributary exhibited flow during a normal period, as determined using the WETS tables, while the consultants were on site. Due to its proximity to agricultural and historical mining activities it provides a direct pathway for pollutants such as herbicides, pesticides, oils and other chemicals to the downstream TNW.
  - f. In reference to the same reasons just cited, organic carbon derived from detritus decomposition, and nutrients within the evaluated wetlands are likely to reach the down slope RPW, and in turn the down slope TNW. These organic carbons are used by downstream organisms as a source of food which increases the overall food chain in the Des Moines River. Due to the hydrologic connection, this provides a benefit to the biological food webs within the RPW and TNW. It has been identified by the IA DNR that the Des Moines River has a biological impairment and must be monitored due to high TMDL values. State and Federal endangered mussel habitat is known to occur downstream of where the RPW discharges into the TNW. They are specifically vulnerable to an increase of sediment in the water and the chemicals that they ingest while filtering the water they live in. The wetlands provide a biological significant nexus to the TNW by filtering out these contaminants that would otherwise enter the TNW and adversely affect the biological integrity of downstream TNW's.
  - g. Based on the above, we have determined that the wetlands identified as Wetlands 1, 2, 3, 4, 5, 6 and 7 (totaling 4.33 acres), the intermittent streams (Stream 1, 2 and 3 totaling 4,164 linear feet) and the open water areas Pond 1 and 2

(totaling 0.90 acres) as described in Snyder and Associates' wetland delineation report possess more than a speculative capacity to provide a substantial or measurable effect on the biological, chemical and physical integrity of the proximate TNW (Des Moines River).






