### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Wetlands identified as wetland area PEMA and PEMC do not exhibit a significant nexus to downstream TNW's. They are depressions located in what appears to be a large pothole like setting. The rim of the adjacent fields surrounding the wetland complex appears to be higher than the surrounding area when viewed on Lidar. No discrete connections could be observed when looking at historical aerial photographs nor on lidar maps. The pond to the north has a ditch that runs towards it and eventually empties into the man-made pond however this flow is from north to south and would not present a connection to the wetlands identified within the project area. The wetlands identified as PEMA and PEMC do look as if they extend outside of the project area however the entirety of the observed wetland complex appears to be encompassed by higher land. When viewed on 1m lidar the wetlands are surrounded by a 3-4 meter higher elevation.





