The vegetated wetland depression is approximately 5 feet wide, originates at a drainage pipe outlet and conveys surface water to the west through an underground pipe. Hydrology for this wetland appears to be maintained through precipitation and surface runoff from the surrounding landscape.
			Wetland 1 consists of a low quality drainageway dominated by primarily invasive and weedy species including a limited mixture of small trees and hydrophytic, herbaceous plants. Vegetative
			dominants identified during the site visit included primarily cottonwood, reed canarygrass and fowl manna grass. Due to its status a manmade drainageway with no direct surface connection to jurisdictional waters, Wetland 1 is isolated and is not a jurisdictional water under the NWPR.
