C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Explain: **The project area is a 4.24 acre parcel of land with a physical address of 4459 S. 13000 Rd. E., Pembroke Township, Illinois, Kankakee County. The project area consists of a plot of land with ridges surrounding the low lying, wetland areas and upland areas. There are remains of a homestead on the property, however, there are no complete buildings currently standing. The topography of the site is generally pretty flat with one section elevated where the home used to be.**

The nearest RPW for the identified wetlands is Beaver Creek, East of the parcel. Wetland 1 is a partial emergent and partially scrub-shrub wetland located in the middle southern border of the parcel located 2,431 aerial feet from the nearest RPW. Wetland 2 is a partially emergent and partial scrub-shrub wetland located in the North-east portion of the parcel, 2,062 aerial feet from the nearest RPW. Wetland 3 is located in the Western portion of the parcel, 2,484 aerial feet from the nearest RPW.

The USGS maps show no evidence of any water features, or blue line streams abutting or adjacent to any of the three wetlands. For each of the three wetlands there is no discreet or confined surface or subsurface connection to a tributary stream that eventually flows into a navigable water of the United States. There are no drainage swales or other features on the topography that would provide justification for a Significant Nexus. They have no outlet, are not abutting any waterway or Waters of the U.S., and the water have no where to flow to.

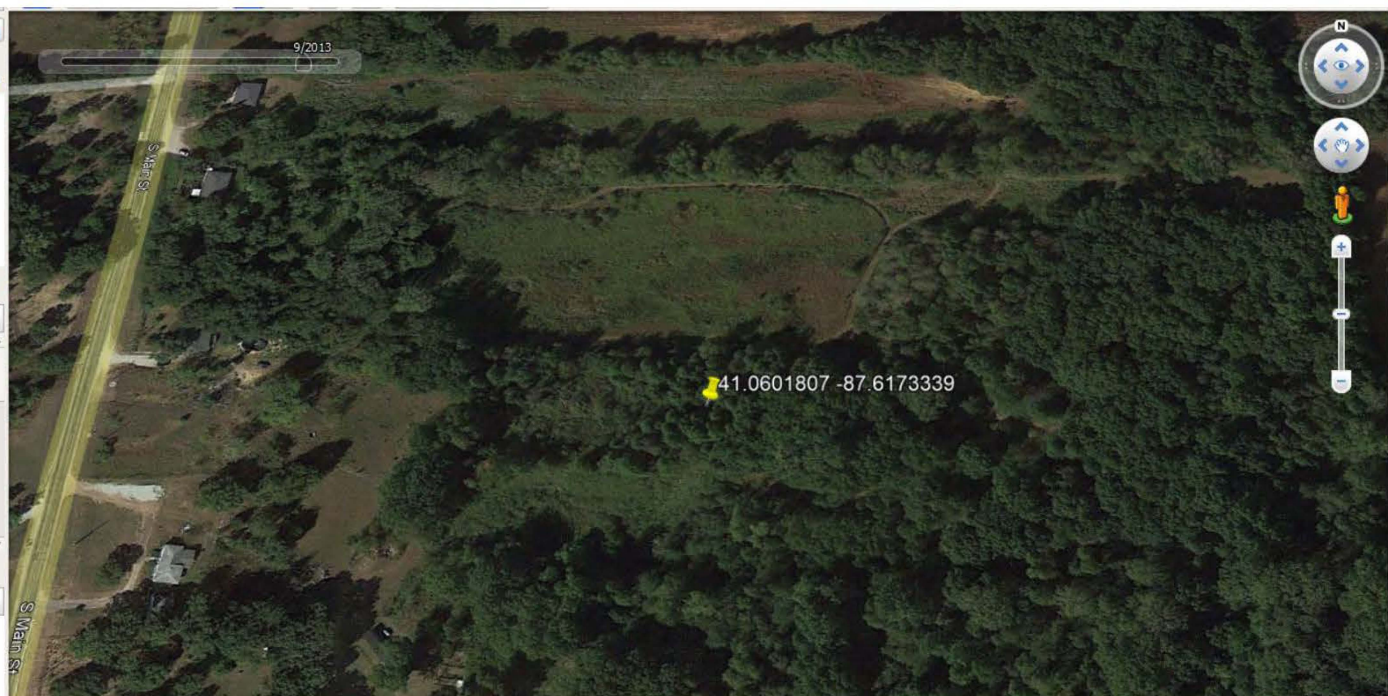

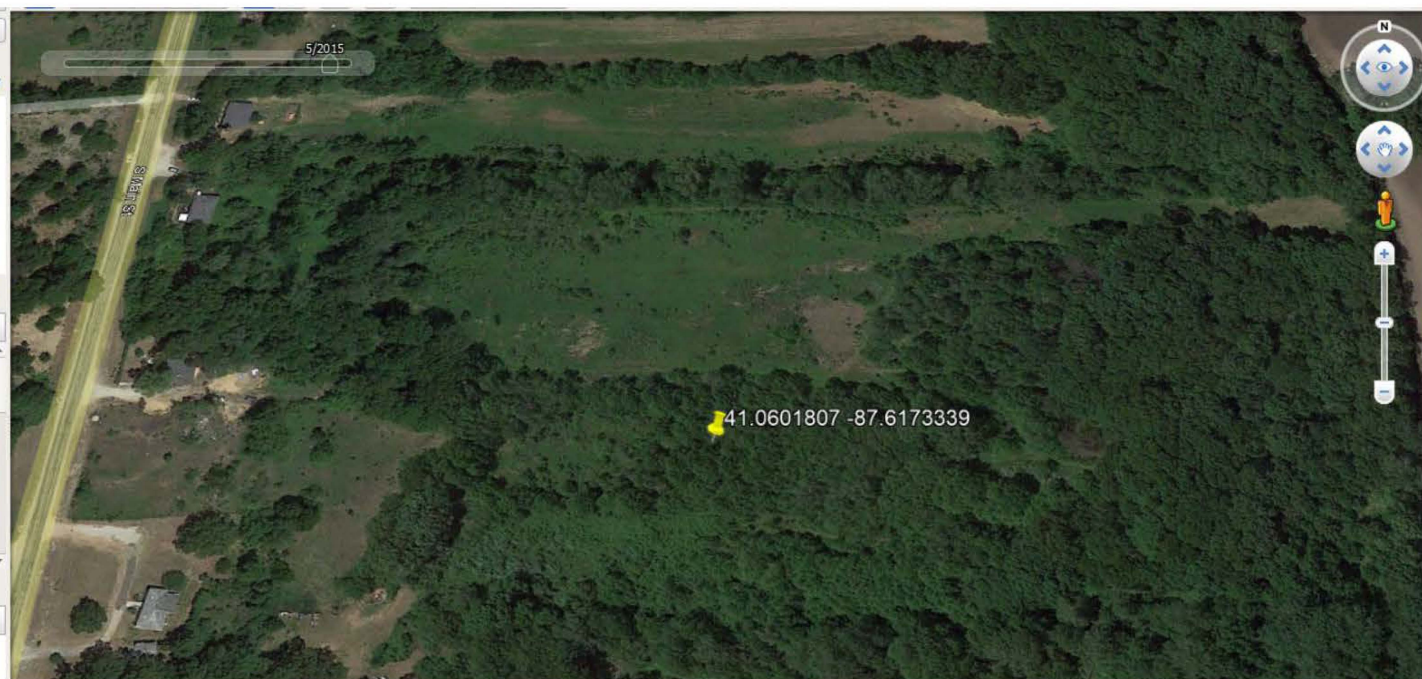
