- **B.** Typical year assessment(s): US Drought Monitor shows the area in a Moderate Drought, which the Antecedent Rainfall Calculator references but shows that the site is in normal conditions.
- C. Additional comments to support AJD: The wetlands and intermittent stream determination was concurred via a desktop review. The photographs of the ephemeral stream were unclear and the LIDAR photograph of that area indicated a possible intermittent stream. A site visit was conducted and upon review of the ephemeral stream, that determination was concurred with. The ephemeral stream had very weak bed/bank and poor indicators of an OHWM. This site also had precipitation the previous two days before the site visit.
