- C. Additional comments to support AJD:** The wetlands on site are isolated and are not adjacent to any waters that flow directly/indirectly into a TNW. The wetlands also do not flow directly/indirectly into a TNW. I conducted a site visit as the LIDAR maps provided by the consultant showed low spots near the edges of the site, all the way to the Missouri River. After the site visit was conducted, it was determined that there were no streams, ditches, or other means for the wetlands on site to flow directly/indirectly into the Missouri River (a TNW).
