C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This project area is approximately 19 acres of farm field. There is one 1.6-acre wetland located in the AJD area. This wetland has no connections to any other WOTUS. This wetland is not adjacent or abutting any WOTUS and there are no known flow paths out of the wetland. The wetland is adjacent to what appears to be a stormwater management facility, just south of the AJD area. This stormwater management facility has no surface water connections and there are no known connections to any other water bodies. There are no waters mapped on the NWI map. There are no waters mapped on the NHD. There are mapped hydric soils, which supports the determination that there is a 1.6 acre wetland on site. The attached map entitled, "AJD Map, MVR-2021-1471, Dated: January 18, 2022", shows the AJD area for this site.
