defined drainage feature or pattern that could feasibly serve as a positive significant nexus point. Lidar of Wetland 2 shows it to be of lower elevation compared to the surrounding agricultural field, likely leading to overland precipitation inundation similar to Wetland 1. According to the NWI map there is an off-site (eastern) forested wetland complex that was investigated for adjacency to Wetland 2. Lidar shows this off-site area of being high elevation with no obvious source of hydrology strong enough to support such a large forested wetland complex. I suspect it is likely not wetland, but can't verify without official data points being taken and review conducted. Data points taken in other suspected wet areas within the agricultural field show a failure to meet any of the three Wetland criteria listed in the 1987 Delineation manual. .

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

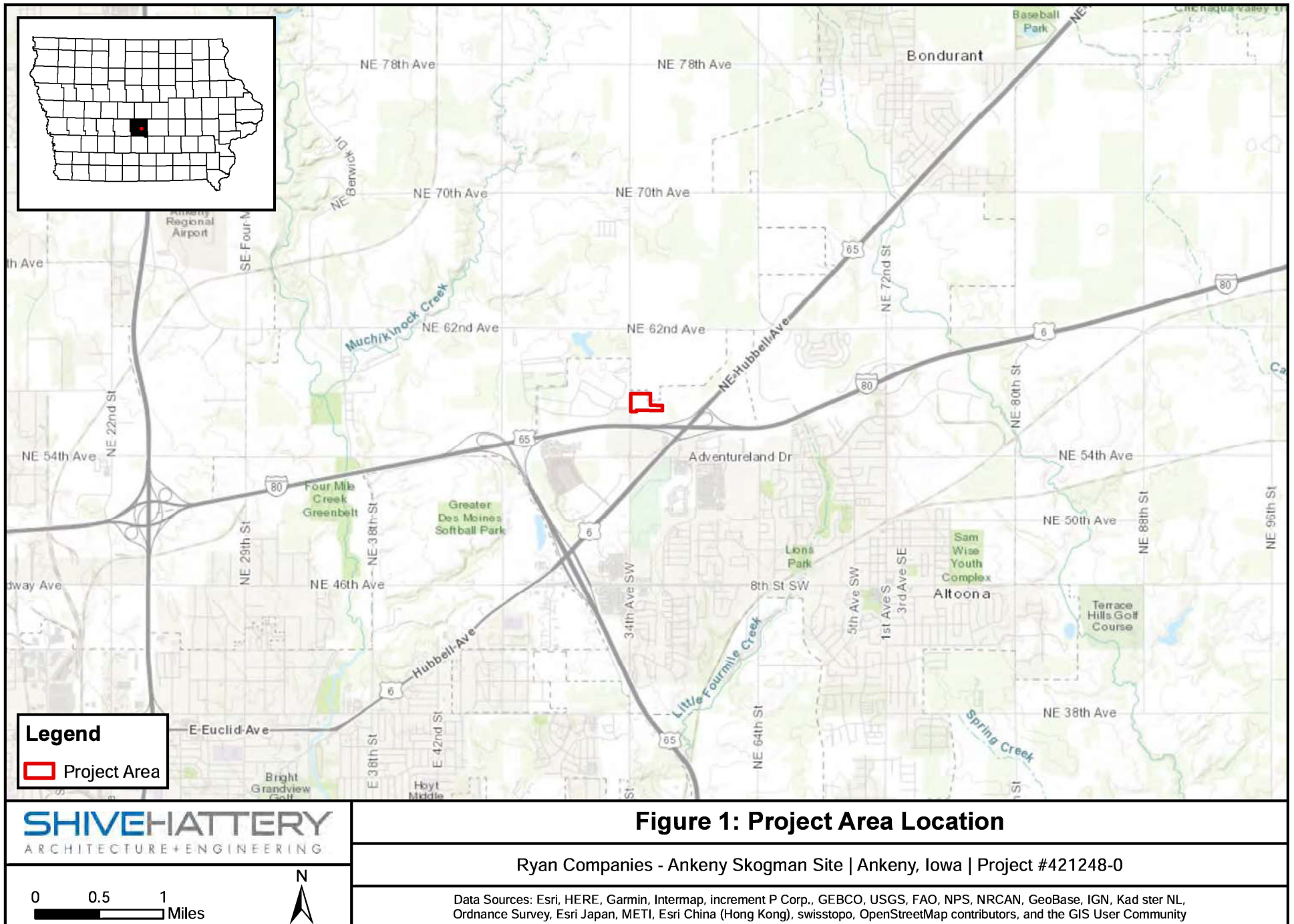

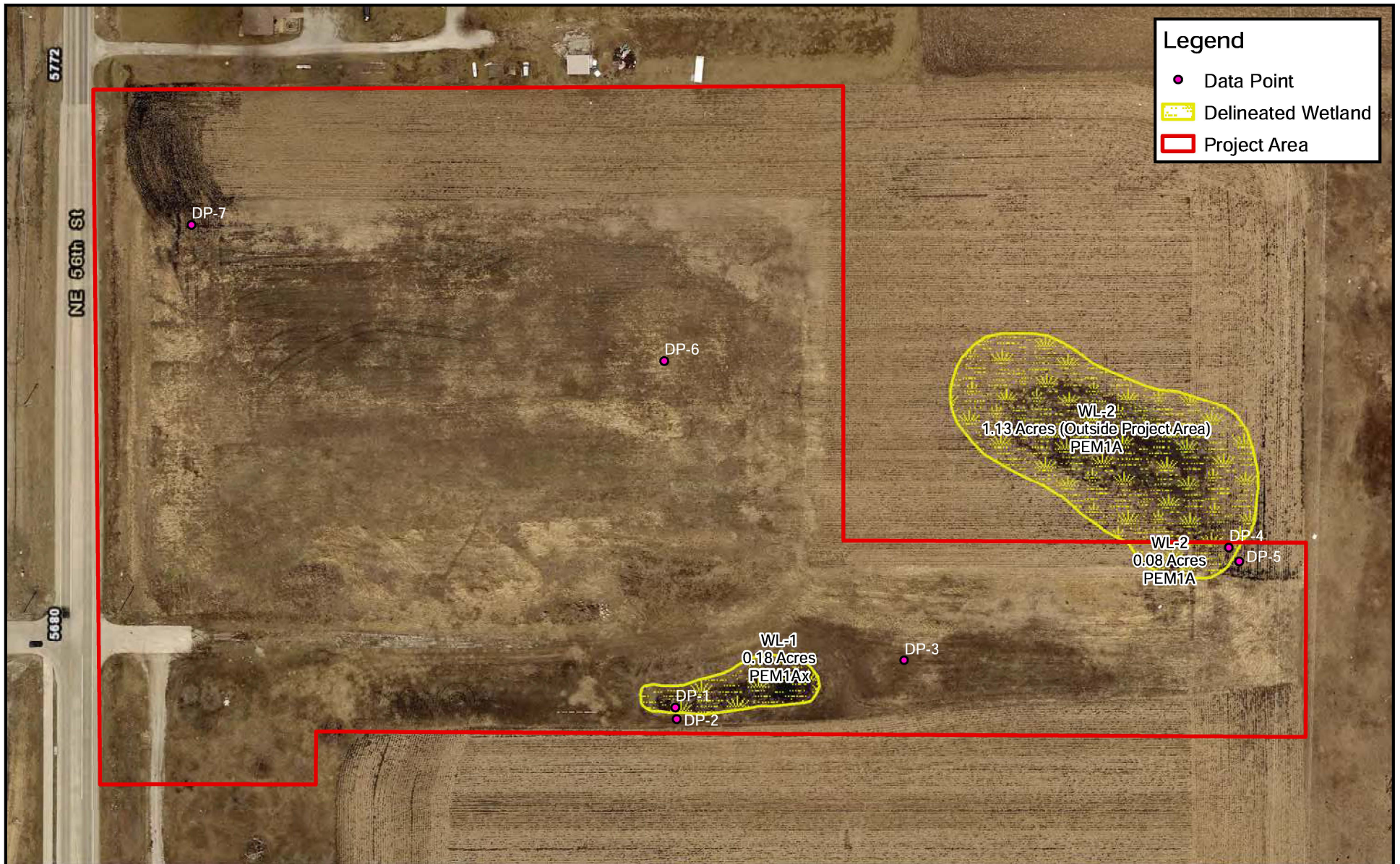

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Applicant submitted a wetland delineation report that annotated two farmed emergent wetlands (WL-1 0.18 acres & WL-2 1.13 acres). Wetland 1 is a depression that was excavated sometime in 2010 to drain an adjacent planned roadway that appears to be since abandoned. This depression lacks any direct connection to a regulated aquatic resource and is shown through past aerials as having variable inundation, most likely pools precipitation and snowmelt. Wetland 2 is an agricultural depression that is first noticed via past aerials in 1970. This wetland lacks a defined drainage feature or pattern that could feasibly serve as a positive significant nexus point. Lidar of Wetland 2 shows it to be of lower elevation compared to the surrounding agricultural field, likely leading to overland precipitation inundation similar to Wetland 1. According to the NWI map there is an off-site (eastern) forested wetland complex that was investigated for adjacency to Wetland 2. Lidar shows this off-site area of being high elevation with no obvious source of hydrology strong enough to support such a large forested wetland complex. I suspect it is likely not wetland, but can't verify without official data points being taken and review conducted. Data points taken in other suspected wet areas within the agricultural field show a failure to meet any of the three Wetland criteria listed in the 1987 Delineation manual. .

**Figure 7: Wetland Delineation**

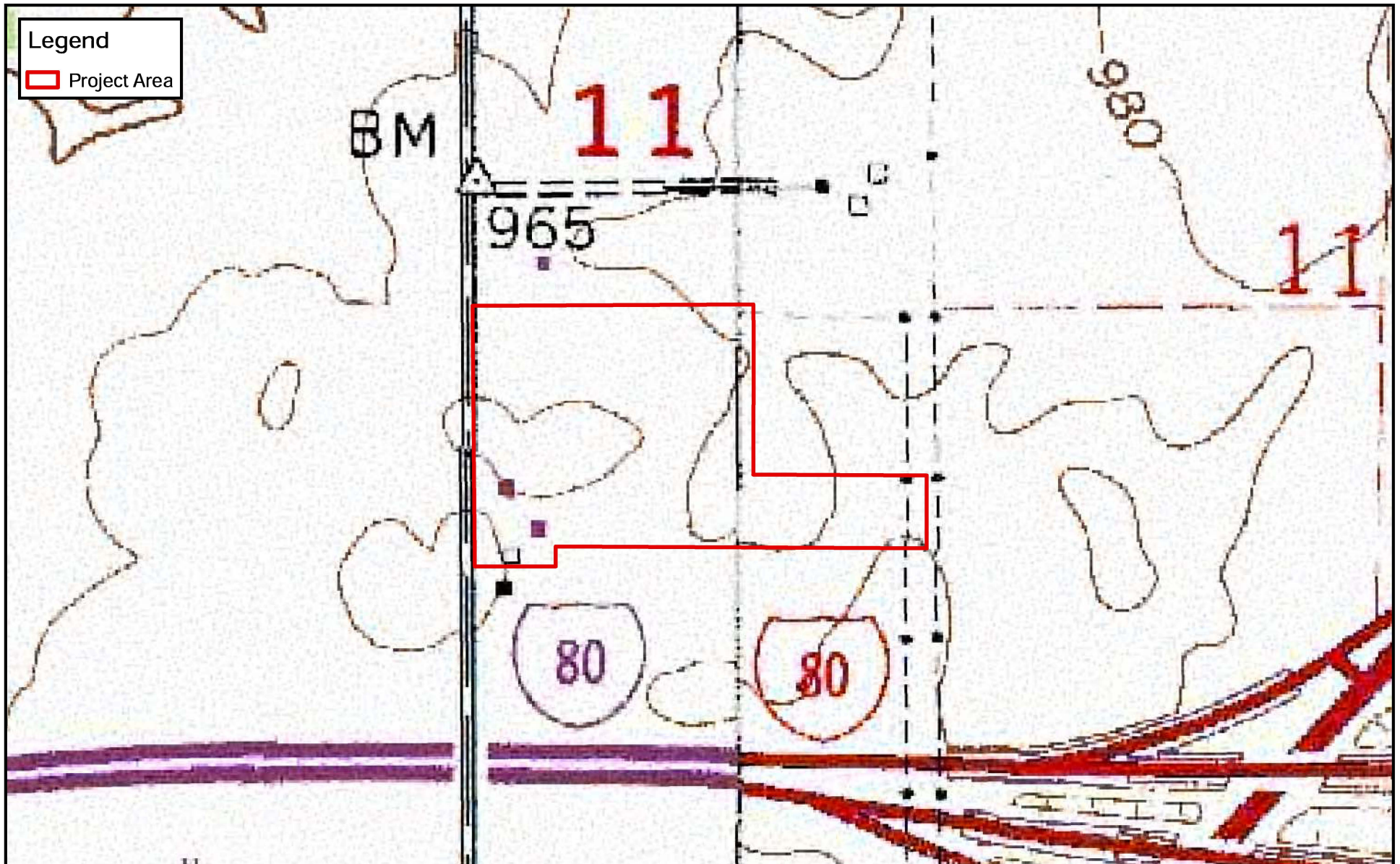

**Figure 3: LiDAR 2-Foot Contour Map**

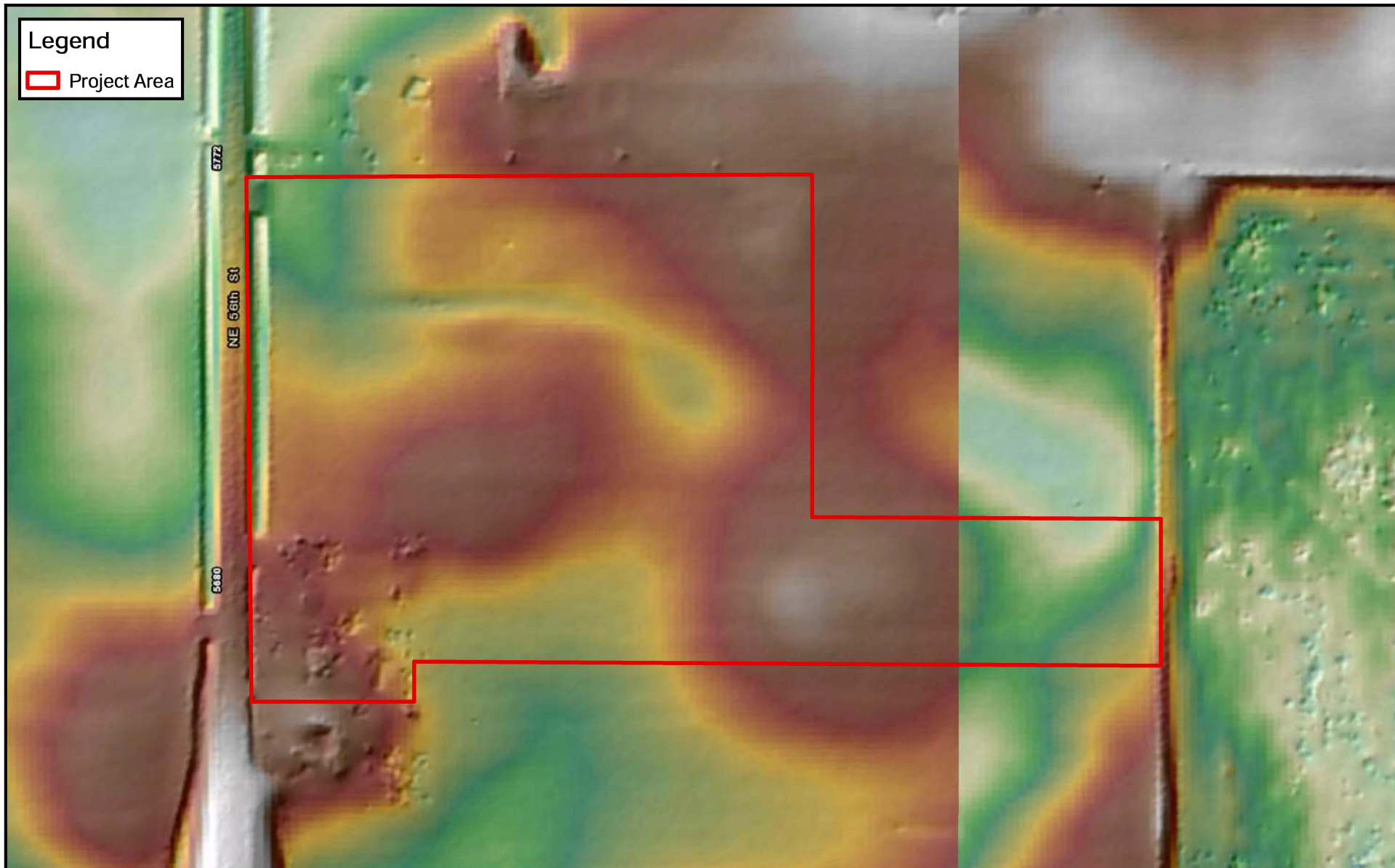

Figure 4: Hillshade Map

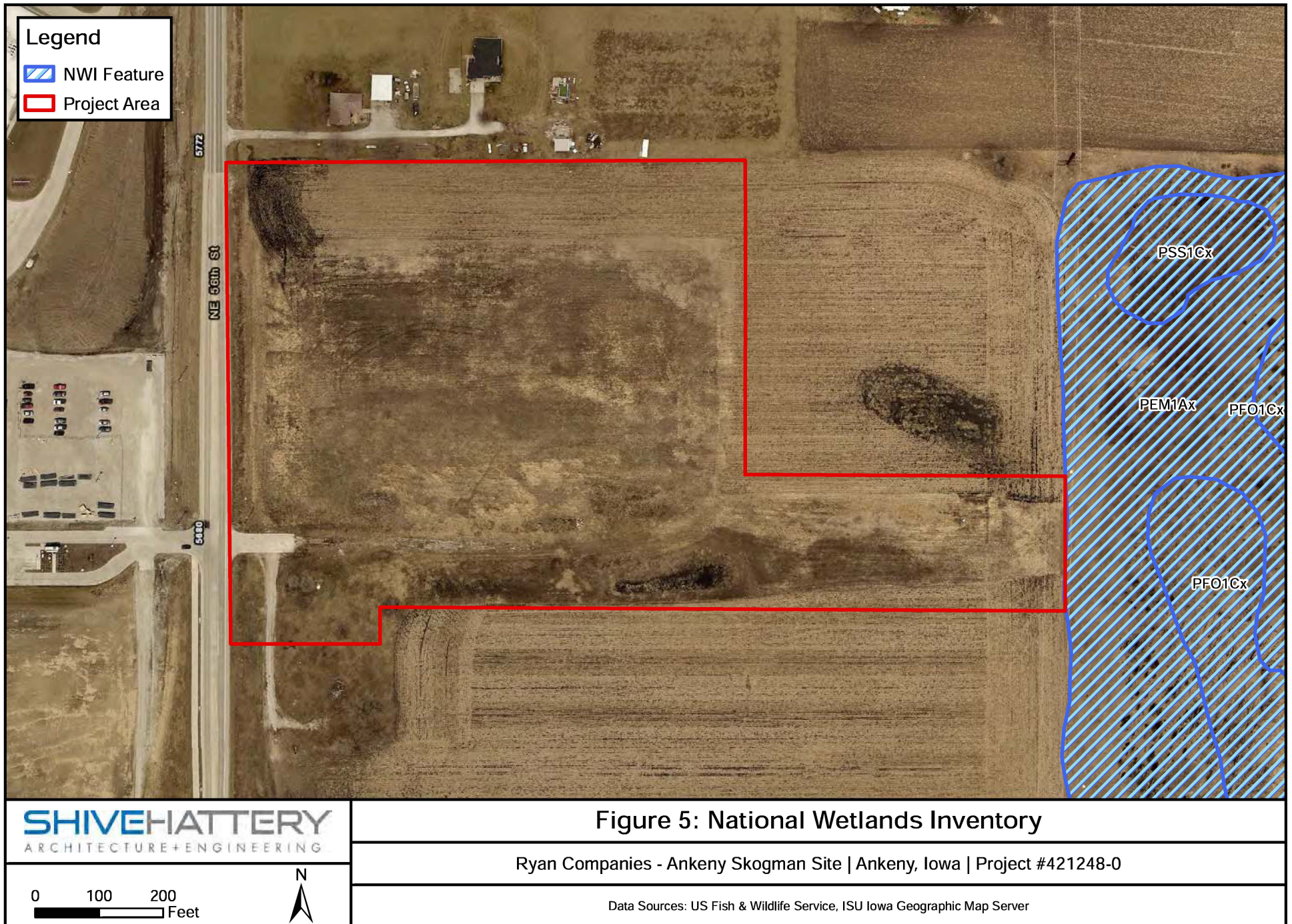
